

## 2022–2023 flu vaccine return policy

### How to request a return

AmerisourceBergen accepts return requests for unused doses for credit at the end of the season based on manufacturers' terms and conditions. All requests must comply with the terms listed below to ensure they are processed appropriately.

### Credit requirements

- Eligible products include:
  - Seqirus™: Up to 10% per presentation
  - Sanofi Pasteur®:
    - > Up to 10% combined total on Fluzone® PFS, SDV, and MDV
    - > Up to 10% each on Fluzone® HD and Flublok®
  - AstraZeneca: Up to 25% on FluMist®
- Non-returnable products include GlaxoSmithKline®: Fluarix® and FluLaval®.
- Vaccine returns may be subject to return freight cost. Freight charges apply to each return authorization and will be deducted from the credit amount or billed separately if applicable.
- Customer may also complete a Federal excise tax (FET) credit only return.
- Credit for returned merchandise will only be issued for items authorized for return by AmerisourceBergen or its entities. All credits will be reflected on the customer's account to apply toward future purchases.
- AmerisourceBergen or its entities will notify the customer if a claim is denied.
- Customer must report order errors, damages and/or discrepancies within 48 hours of receiving refrigerated items. AmerisourceBergen or its entities are not obligated to issue credit for errors or discrepancies that are not reported within this time frame.
- Credit is issued at the original purchase price shown on the invoice, less the amount of off-invoice allowances or adjustments, if any.

### Product requirements

- Product(s) must be received at AmerisourceBergen or its entities on or before **3/31/23**.<sup>1</sup>
- AmerisourceBergen or its entities will accept unused prefilled syringe doses and single dose vials. Whenever possible, please keep doses in their original packaging. Multi-dose vials can only be accepted as a whole unit in the manufacturer's original packaging.
- AmerisourceBergen or its entities is not obligated to process return requests for damages resulting from deliveries to changed shipping addresses and/or customer business hours that were not communicated to AmerisourceBergen prior to the shipment.
- Certain items are non-returnable, including but not limited to:
  - GlaxoSmithKline: Fluarix and FluLaval
  - Items not invoiced by AmerisourceBergen or its entities
  - Partial vials
  - Special sale items or special terms communicated to customer at time of sale as non-returnable
- AmerisourceBergen or its entities may require a signed PDMA to accept an eligible return.
